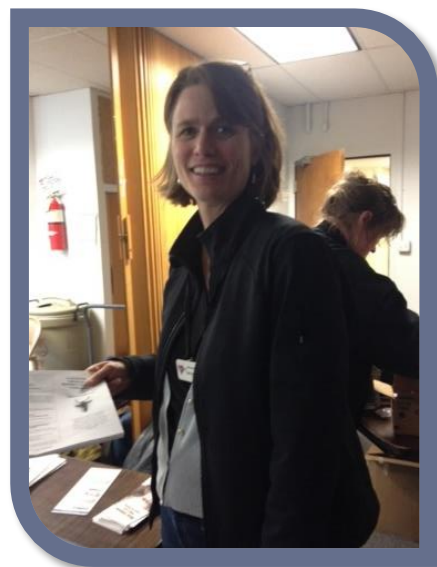
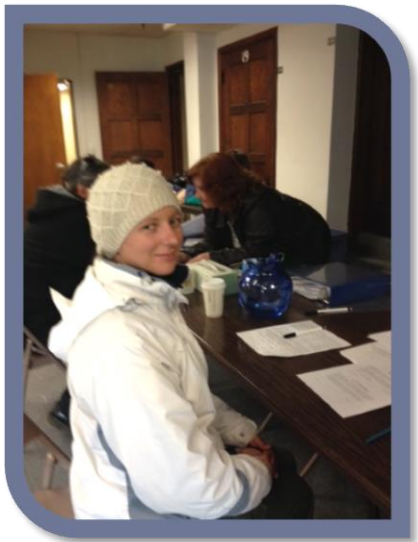

## 2015 Highlights

- ✓ Over 35 volunteer Health Care professionals, Spanish translators and other volunteers provided **greater than 9000** Health Care services to guests via 13 Free Clinics per month and the Don Burt Community Care Program!
- ✓ Over 45 key volunteers provided over **3000** hours of volunteer time equating to **\$104,556** Value of Volunteer Service Time!
  - This breaks down as follows: **\$54,305.25** in Clinical Value for Volunteer Service Time and **\$50,250.82** non-Clinical Value for Volunteer Service Time.
- ✓ **319** Physician or Nurse Practitioner visits were provided at no cost.

- ✓ **558** Nurse visits were provided at no cost.
- ✓ **169** Paramedic visits were provided at no cost. Greater than 300% increase from 2014!

- ✓ Over 260 health service referrals were made.
  - These included: Clinica Campesina, People’s Clinic, Dental Aid, Mammography, Salud Clinic, HopeLight Clinic, Longmont Community Health Network, Primary Care Physicians, Urgent Care and the Emergency Room
- ✓ In partnership with Boulder Community Hospital 11 patients received flu shots at no cost and 46 patients received foot care via the Sunday Free Clinics.
- ✓ In-Kind donations such as handmade hats, socks, personal care items, medical supplies, dental supplies, medications and office supplies exceeded \$5,900 in value.

## Executive Director’s Report

2015 has been another exciting and inspirational year for St. Benedict Health and Healing Ministry (SBHHM). Our dedicated group of volunteer health care professionals, translators and other volunteers has grown and changed over time. People continue to be deeply moved and connected in the service they offer to the thousands of adults in Boulder County who are medically underserved. In the words of one volunteer, “working with SBHHM is my life blood, it gives my life purpose and nurtures me deeply.” Many of our volunteers have been with us for over 10 years!

Although we witness numerous situations of personal tragedy, trauma and destitution at our clinics, we are deeply moved by the profound humility and gratitude of the patients we serve and the teamwork amongst our health care professionals.



Despite the political and economic landscapes, the need for health care services amongst the population SBHHM serves remains high. Many of our patients, for a multitude of reasons, resist the health care system. Sometimes it’s just too overwhelming for them to participate in. Others are plagued by their mental and physical disabilities.

In February this year our 9th Annual Heart Art Fundraiser welcomed over 150 guests and raised over \$26,000! It was an evening of inspiration as we heard from Michael, a patient from our clinic at the OUR Center in Longmont and our Medical Director, Dr. Eugene Chu. During Heart Art a representative from the American Contract Bridge League presented a very generous check for \$4,300 to the Board of Directors. In addition, generous donors matched the Kerr Foundation grant enabling us to raise an additional \$5,000. In October we launched our first Boogie Bash at the Yoga Pod in Boulder. Costumes and dancing contributed to a fun evening had by all.

New developments in 2015 include creating relationship with Boulder Housing Partners and beginning an every other month free clinic at their Canyon Pointe location. Since this is residential housing, we've been able to follow up with patients over the year and have provided 65 nurse visits. In addition, a formal partnership with Dental Aid began in June. Through our Medical Financial Assistance Program, SBHMH is able to pay for all or a portion of qualifying patient's dental treatment plans.

As we look toward 2016 we will be evaluating additional free clinic sites and new partnerships as well as expanding our clinics and services at the OUR Center in Longmont.

The Board of Directors welcomed: Mr. William Eliason who brings financial analysis expertise. SBHMH continues to grow a strong, diverse and committed Board of Directors. Several new volunteers were welcomed to the SBHMH team: Ms. Peggy Martin, paramedic; Mr. Darren Conradson, paramedic; Dr. Julie Fischer, MD; Ms. Beth Kimberly, Heart Art; and Ms. Susan Spitz, RN.

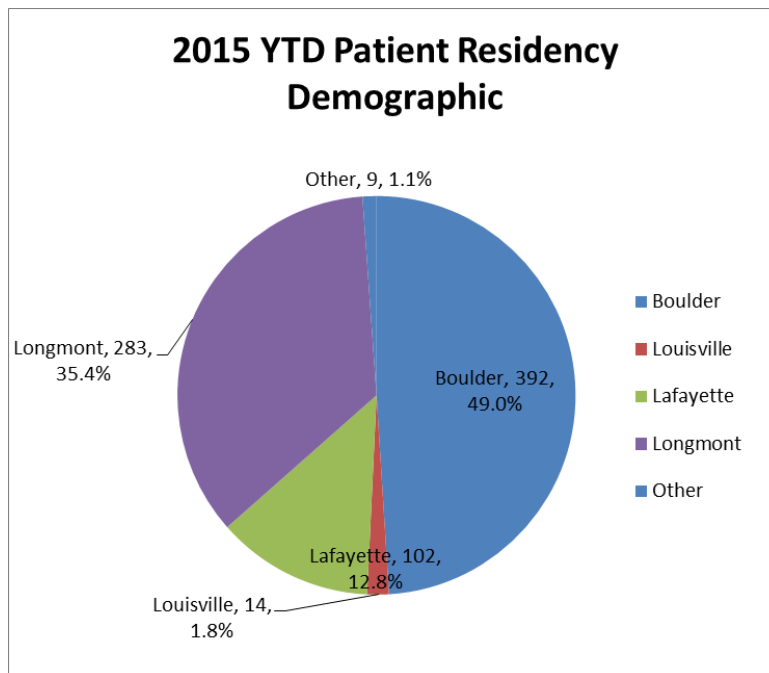
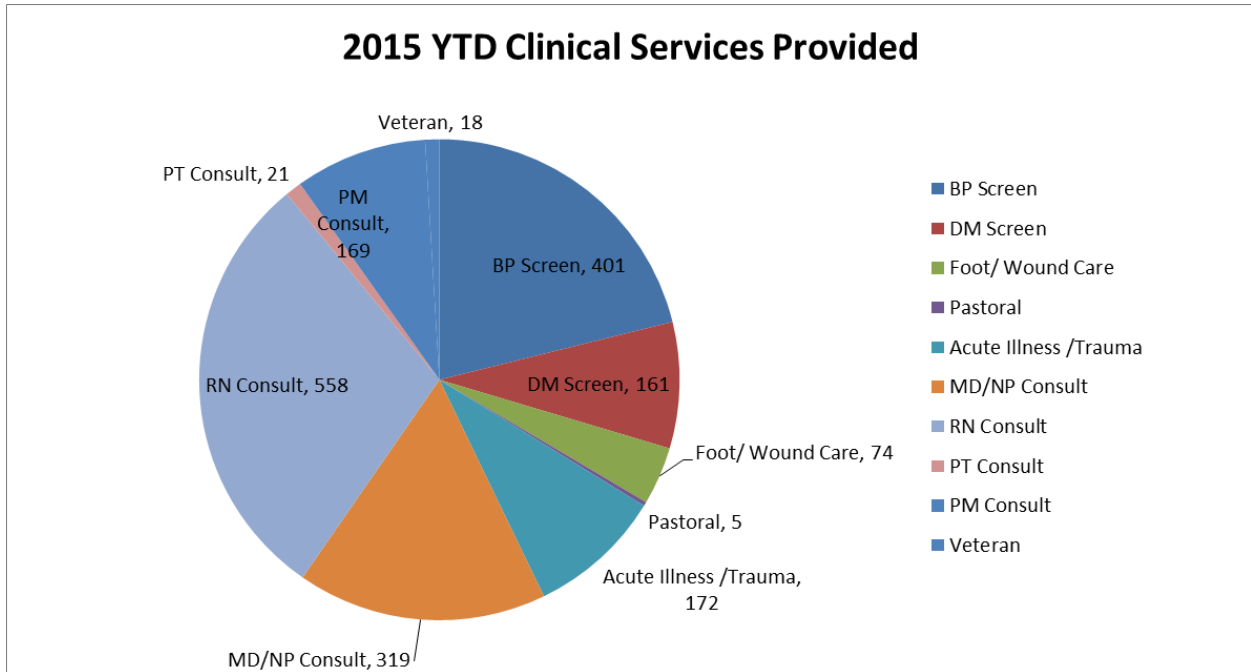

## Medical Director's Annual Report 2015

In 2015, thanks to the skill, dedication and compassion of its wonderful volunteers, providers and staff, St. Benedict Health and Healing Ministry continued to evolve its important and integrated role in the health care safety net of health care in Boulder County.

Patients of St. Benedict's often have unmet dental health needs. In 2015, by utilizing our Medical Financial Assistance Program, St. Benedict's was able to partner with Dental Aid clinics in Boulder, Louisville and Longmont to provide access to much needed dental health services. Our first two patients have received care through this program with encouraging results and feedback.

We continued our partnership with the Longmont Community Health Network (LCHN) as part of a federally funded grant obtained by LCHN. In 2014, St. Benedict's entered into a collaborative with the LCHN, the OUR Center and Hopelight clinic to provide coordinated services to the indigent in Longmont



with a special focus on case management and the delivery of care at the point of habitation. In 2015, to help meet the needs of this initiative, St. Benedict's expanded its services at the OUR center to weekly clinics.

Meanwhile, our dedicated group of nurses, physicians, nurse practitioners, physical therapists and foot care nurses continue to staff clinics providing diabetes care, blood pressure management, foot and wound care, health education, pastoral visits and care coordination

in clinics throughout Boulder County. St. Benedict's continues to work closely with St. John's Episcopal Church, Trinity Lutheran Church, First Congregational Church and the Sister Carmen Community Center by providing health care services in parallel to the compassionate care programs already in place in each organization.

St. Benedict's also continues the Don Burt Community Cares program in a joint venture with BOHO. St. Benedict's non-medical volunteers provide much needed over the counter medications (aspirin, Tylenol, Motrin, antacids...) and daily comfort essentials (hand lotion, Q-tips...) to the homeless in Boulder County who access the emergency warming shelters during the winter months.

It is an honor to be part of St. Benedict Health and Healing Ministry and we look forward to continuing to provide health care services to the underserved in Boulder County with our many partnering organizations.

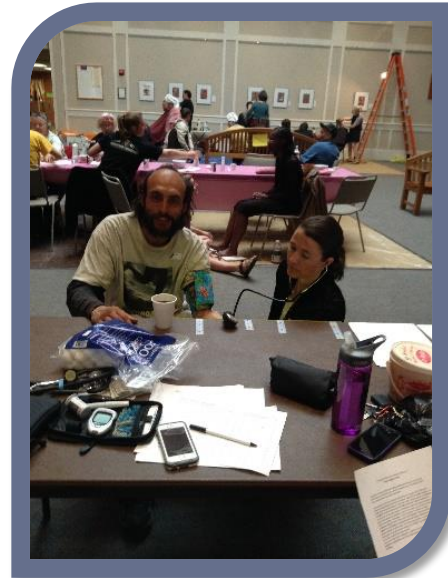
## Treasurer's Annual Report 2015

St. Benedict Health and Healing Ministry ended the year with a \$ 13, 978 surplus, slightly less than in 2014. Lower than expected expenses coupled with continued Diocesan and community support, including our initial participation in Colorado Gives Day provided this surplus.

In Summary for the 2015 St. Benedict Health and Healing Ministry Income Statement, Cash donations totaled \$129K while In-Kind donations were \$110.5K, for a total of \$239.9K for all Income sources. Correspondingly, Cash expenses totaled to \$115.4K, while In-kind expenses were \$110.5K, for a total recognized expenses of \$225.9K. The resulting Net Income was \$14K (rounded) for 2015.
